Applications:

- Applications must be postmarked by <u>February 19, 2016</u>
- The application fee is \$35. Please enclose a check, payable to the Fox Valley Orchestra with the Application Form. The application fee is not refundable. *Late applications will not be accepted.* Keep this sheet for future reference.

Auditions:

- This competition will be held on Saturday, February 27, 2016
- Between 2pm and 9pm at the Fox River Academy of Music & Art
- 26 W. Van Buren Street, Oswego, IL 60543.

Awards:

• 1st Place: \$500 and performance with the Fox Valley Orchestra

• 2nd Place: \$250

Application Requirements and Eligibility:

- A completed Application Form.
- Must be of high school age on the date of the competition.
- Competition is open to the following orchestral instruments: piano, woodwinds, brass, strings, percussion, harp, classical guitar, and voice.
- The winner(s) of the competition will perform with the Fox Valley Orchestra at its June 26, 2016 performance.
- The winner(s) must be available for two rehearsals prior to the performance date: the evenings of June 12 and June 19, 2016.

Audition Requirements:

- Applicants should perform one movement from a standard concerto for their instrument or a similar work. The movement of your concerto must not exceed ten (10) minutes in length and orchestral accompaniment must be available for the piece. The Fox Valley Orchestra reserves the right to refuse a piece based on cost or availability.
- Auditions may be performed with piano accompaniment. You must provide your own accompanist.
- Memorization is not required but strongly recommended.
- Contestants must provide at least three (3) copies of their composition for judge's use. These may be photocopied.
- Auditions are not open to the public or family members.
- Auditions will last 10-15 minutes. Because of time limitations please enter the audition room warmed up and ready
 to perform. The judges may ask you to stop or cut to another spot. This does not necessarily reflect your
 performance.

Judges:

- First impressions are important to judges. This includes your appearance and attire.
- Judges may elect to choose a single winner, several winners, or no winner. All judges decisions are final.
