Applications:

- Applications must be postmarked by March 6, 2017
- The application fee is \$25. Please enclose a check, payable to the Fox Valley Orchestra with the Application Form. The application fee is not refundable. *Late applications will not be accepted.* Keep this sheet for future reference.

Auditions:

- This competition will be held on Sunday, March 12, 2017
- Between 2pm and 5:30pm at the New England Congregational Church
- 406 W. Galena Blvd, Aurora, IL 60506.

Awards:

- 1st Place: \$500 and solo performance with the Fox Valley Orchestra Chorus
- 2nd Place: \$250

Application Requirements and Eligibility:

- A completed Application Form.
- Must be of high school age on the date of the competition.
- Competition is open to all voice parts.
- The winner(s) of the competition will perform with the Fox Valley Orchestra & Chorus on their April 29 & 30, 2017 performances.
- The winner(s) must be available for the last two rehearsals prior to the performance date on April 16 & 23, 2017.

Audition Requirements:

- Applicants should perform a standard classical voice solo. Inquiries may be made ahead of time on acceptable works. The music should not exceed ten (10) minutes in length and orchestral accompaniment must be available for the piece. The Fox Valley Orchestra reserves the right to refuse a piece based on cost or availability.
- Auditions may be performed with piano accompaniment. You must provide your own accompanist.
- Memorization is not required but strongly recommended.
- Contestants must provide at least three (3) copies of their composition for judge's use. These may be photocopied.
- Auditions are not open to the public or family members.
- Auditions will last 10-15 minutes. Because of time limitations please enter the audition room warmed up and ready to perform. The judges may ask you to stop or cut to another spot. This does not necessarily reflect your performance.

Judges:

- First impressions are important to judges. This includes your appearance and attire.
- Judges may elect to choose a single winner, several winners, or no winner. All judges' decisions are final.
